Energy Infrastructure products include low-, medium- and high-voltage power distribution and power transmission products as well as extra-high-voltage underground cable systems. The Electrical Infrastructure and Construction product families are comprised of application-specific cables for uses such as electrical power generation (traditional fuels, alternative and renewable sources, and distributed generation), the on- shore or off-shore oil, gas and petrochemical industries, mining, industrial automation, automotive, marine, military and aerospace applications, power applications in the telecommunications industry, residential and non-residential electrical installation and other key industrial segments. Communications wire and cable products transmit low-voltage signals for voice, data, video and control applications, including undersea communications cable systems.
